#### 1. Acceptance

- Registration is subject to acceptance on a "first-come-first-served" basis; Priority for PolyU staff and students.
- The School may in its absolute discretion accept or reject the Application without providing any reasons.

## 2. Payment

- a) Payment is not refundable.
- b) Participants are required to settle the course fee within 5 days after registration. Otherwise enrolment may be rejected.
- c) When the Application is accepted by the School, the Applicant will become a Participant. If the Applicant subsequently wishes to withdraw its participation, the course fee is not refundable.
- d) Registration cannot be confirmed until the payment transaction has been completed.

## 3. Termination Policy & Cancellation and/ or Changes

- a) The School reserves the right to change the course contents, schedule, speakers, date, time /or venue as necessary.
- b) Participants will be fully refunded when there is insufficient enrolment leading to the cancellation of the course.
- c) The School reserves the right in any circumstances to cancel the course for example because of an insufficient number of participants or for whatever reason. The School's liability shall be limited to the amount of the fee paid by the participant for that course.
- d) The School shall not be liable to any Participant for any delay, non-performance of services, loss or damage arising from any cause or causes beyond its reasonable control including, without limitation, any of the following: act of God, governmental act, war, terrorist attacks, fire, flood, earthquake, storm, tsunami, embargo, explosion or civil commotion. In such an event, the School reserves the right, at its sole discretion, to:
  - (i) Postpone the course and/ or alter the dates of the course as necessary without any refund due to the Participant; or
  - (ii) Cancel the course and offer Participants a refund subject to the deduction of any costs already paid by the School which are otherwise unrecoverable through School's service providers.

## 4. Exclusion of Liability

- a) The School shall not be liable for any loss, damage or personal injury howsoever suffered by or caused to the Participant or its officers, representatives, agents, employees or any third party, or other property in the course or in relation to the course.
