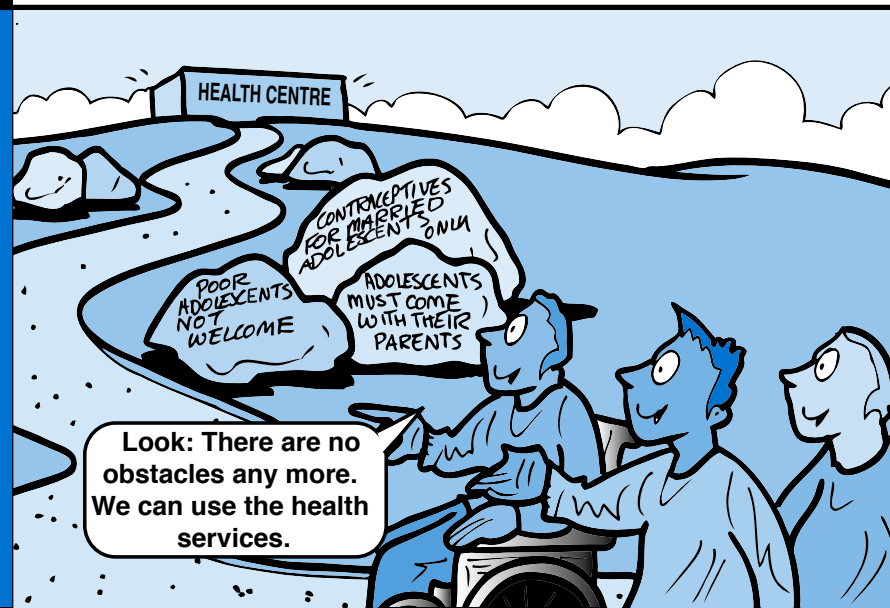


## CHARACTERISTIC 1

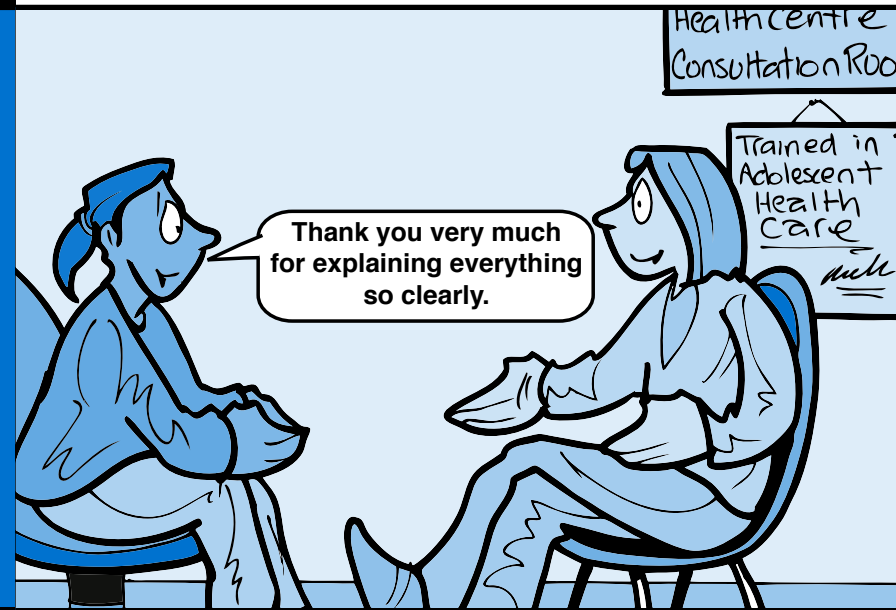
